Organizers of Virtual Vancouver NAVSA 2022, "Unsettling Victorians," respectfully acknowledge our privilege of working and living on the unceded traditional territories of the Skwxwú7mesh Úxwumixw (Squamish), səlilwətaʔł (Tsleil-Waututh) and xwməθkwəyəm (Musqueam) qicəy (Katzie), kwikwəλəm (Kwikwetlem), Qayqayt, Kwantlen, Semiahmoo and Tsawwassen peoples. We extend our respect to all First Nations, Inuit, and Métis peoples, and we encourage participants in this conference to acknowledge and learn about your own relations to ancestral lands. The banner image for this conference is also a land acknowledgement of sorts (see vintage postcard on our cover). In the late nineteenth century, the picturesque village nestled along the north shore of Stanley Park in Burrard Inlet was home to a diverse community of primarily Coast Salish Indigenous women and their non-Anglo European husbands and children. It was a diasporic as well as an ancestral settlement. The land was expropriated from these families in 1931 when, after multiple court battles, the Canadian and local governments achieved the legal power to remove them from the park for the enjoyment of a rapidly consolidating settler colonial public. The legacy of dispossession and violence this image both captures and obscures underlines the difficult and complex matters our "unsettling" conference intends to engage.

#### WELCOME TO VIRTUAL VANCOUVER NAVSA

We're absolutely delighted to welcome you back to NAVSA after such a long and exhausting hiatus. We hope you and your loved ones have made it through these challenging past two years in safety and good health. Though we desperately wish we could have met in person, we are thrilled to come together at long last even virtually.

Despite the change of format, our original setting in downtown Vancouver, British Columbia, on traditional, ancestral, and unceded Coast Salish territory remains extremely significant as the defining context for this event. The original location of the conference, on the Pacific Ocean and beside historic Stanley Park, approaches Victorian global empire from a transpacific and transcontinental perspective, and the belated entry of the region into Britain's imperial orbit highlights the pressing presentness of the nineteenth-century colonial past. This geographical and temporal particularity offers a provocative space for rethinking Victorian studies differently. "Unsettling Victorians," interpreted in the broadest sense, is inspired by the wide-ranging resonances of our settler-colonial setting and foregrounds the challenges of doing Victorian studies in an era of decolonization.

The theme of the conference is designed to incite thinking about the sorts of things that unsettled the Victorians while also reflecting on what is unsettling about the Victorians for those of us who study them today. We wanted to consider what sort of work might be necessary to unsettle all things Victorian - from genres, themes, and objects of study to the period, the classroom, the

discipline, the humanities, and the institution of the university. The conference fosters discussions that develop a critical perspective on settler and colonial identities, cultures, environments, structures, and assumptions; incorporate Indigenous topics, issues, methodologies, or ways of knowing; explore decolonial approaches, strategies, or techniques in Victorian literature, culture, history, pedagogy. The conference also features a broad range of papers, panels, round tables, and digital projects on many aspects of our general theme, including questions about history and the way we memorialize the past, environmental crisis and the anthropocene, race and empire, globalization, and nineteenth-century new media and digital humanities.

Despite the many changes in our lives since the start of the pandemic, our "Unsettling Victorians" theme remains as relevant today as ever. Oddly, the sudden change of format has opened new "unsettling" possibilities. First, this is possibly the most geographically diverse NAVSA ever. We are delighted to welcome presenters and participants from six continents, from places such as China, Singapore, Japan, South Korea, India, Australia, New Zealand, South Africa, Germany, Turkey, Greece, and Chile. This conference started out disrupting the "V" in NAVSA," but its expansive geographic reach also applies an unexpected decentering pressure on the "NA" in NAVSA. Second, geographic redistribution raises a concomitant confusion around temporality. The "standard" time for this conference is PST but for the conference database it is EST; meanwhile, folks from other parts of the globe may find themselves joining in the wee hours of the night. Whose time zone is the standard and how is that standard decided? Finally, alongside such questions arising from the interesting materially unsettling conference experience, the digital format has also enabled a degree of accessibility, diversity, and inclusion that cannot be achieved in person. Opening up this conference more widely is vital to the health of this organization and the future of the discipline, and we offer a hearty welcome to the many students who have joined our ranks. In short, the migration online has facilitated our conference themes in ways we had not anticipated. We wish you a generative and enjoyable Virtual Vancouver NAVSA 2022.

#### KEYNOTE SPEAKERS

# **Armand Garnet Ruffo (Queen's University) A Matter of Fact and Feeling**

In light of what Indigenous literary scholar Dian Million calls "felt scholarship," I will begin with my childhood in remote northern Ontario and consider what led me to a literary career with a lifelong interest in Indigenous histories. I will trace the impact of hidden family and community histories on my work and the trajectory that led to my poetic-biography Grey Owl: the Mystery of *Archie Belanev*. By way of problematizing the relationship between "measured" objective historicism and "personal" literary subjectivity, I will reference my biography Norval Morrisseau: Man Changing Into Thunderbird and my libretto "Sounding Thunder: The Song of Francis Pegahmagabow." Lastly, I will refer to my latest project, which considers mid-19th century Upper Canada by merging history and literature in the application to understand and feel a period of tremendous change for Indigenous peoples.



Armand Garnet Ruffo is a member of the Chapleau Cree First Nation in northern Ontario. He is the author of *Norval Morrisseau: Man Changing into Thunderbird*, a finalist for a 2015 Governor General's Award, and five books of poetry, including *Treaty #*, a finalist for a 2019 Governor General's Award. He has written an award-winning feature film, *A Windigo Tale* (2010), and has edited (*Ad)Dressing Our Words: Aboriginal Perspectives on Aboriginal Literatures* (Theytus Books, 2001), *An Anthology of Canadian Native Literature in English* (OUP, 2013), *Introduction to Indigenous Literary Criticism in Canada* (Broadview, 2016) and *An Anthology of Indigenous Literature in Canada* (OUP, 2019). Other projects include a libretto for the musical *Sounding Thunder: The Song of Francis Pegahmagabow* (2018) and *On The Day the World Begins Again* (2019), video-poem about Indigenous peoples' incarceration. His current project is set in mid 19th century Upper Canada. Ruffo is the Queen's National Scholar in Indigenous Literatures at Queen's University in Kingston, On

# Brenna Bhandar (University of British Columbia) Cultivating the Soil: Use, Improvement and the Colonial Conditions of Our Present


Cultivation would come to function, throughout the British colonial world, as a justification for the appropriation of Indigenous lands. Narrowly defined by a political imaginary of private ownership and market exchange, cultivation was intimately tied to an ideology of improvement. The ideology of improvement that characterised settler colonialism in British Columbia, as elsewhere, bound together the twin ideas that land not cultivated was legitimately open for appropriation, and that its inhabitants required civilizational improvement so they too could enjoy the fruits of possessive individualism. This use of the concept of improvement to impose private property relations where they did not previously exist, in conjunction with a racial order of white supremacy, is captured by the term "racial regimes of ownership". Indigenous lands – designated as waste and therefore ripe for appropriation – continue to be laid waste by modern forms of use that privilege extraction and exploitation at the expense of myriad forms of life, in a moment of intensified speculative accumulation that has land at its centre.



Dr. Brenna Bhandar is Associate Professor in the Allard Law Faculty, UBC. Prior to joining Allard she was Reader in Law and Critical Theory at SOAS, University of London. She is author of *Colonial Lives of Property: Law, Land and Racial Regimes of Ownership* (DUP: 2018) and co-editor (with Rafeef Ziadah) of *Revolutionary Feminisms: Conversations on Collective Action and Radical Thought* (Verso: 2020).

## Cannon Schmitt (University of Toronto) Notes Toward a Water Acknowledgement

In Canada, particularly in academe, one outcome of the work undertaken by the Truth and Reconciliation Commission (TRC, 2008-15) has been the widespread adoption of land acknowledgements. Modelled on Indigenous practices of recognizing one's relation to the ground on which one stands, land acknowledgements disallow settler amnesia by reminding those of us who are not Métis, Inuit, or members of one of the First Nations that we live our lives in places that originally belonged to someone else—in the case of Vancouver, the x<sup>w</sup>məθk<sup>w</sup>əyəm (Musqueam), Skwxwú7mesh (Squamish), and Səlílwətał (Tsleil-Waututh). From its inception in the 1950s, Victorian Studies has documented and explored the consequences of nineteenth-century British dispossession of non-British peoples; land acknowledgements highlight the increased importance of this activity as a central vocation of the field. But they also suggest the possibility of a supplement that would recognize it's not only land that was and is home, contact zone, and contested inheritance. For example: the three Indigenous nations on whose unceded territory this conference will be held belong to a group of peoples known collectively as the Coast Salish, and the city that has come to occupy part of that territory bears the name of a British naval officer, George Vancouver. Indigenous relations with seas and rivers, the ocean as a site and vector of conquest, and much else besides confirms the need for something like a water acknowledgement. Imagining what such a thing might look and sound like, this talk hopes to show one way to do Victorian Studies, per Christina Sharpe, in the wake—of the TRC, of empire, of settler colonialism.



Cannon Schmitt is the author of two monographs: Alien Nation: Nineteenth-Century Gothic Fictions and English Nationality (Pennsylvania, 1997) and Darwin and the Memory of the Human: Evolution, Savages, and South America (Cambridge, 2009). With Nancy Henry, he co-edited the collection *Victorian* Investments: New Perspectives on Finance and Culture (Indiana, 2008). With Elaine Freedgood, he co-edited a special issue of Representations titled Denotatively. Technically, Literally (2014). His essays have appeared in Representations, ELH, Victorian Studies, Victorian Literature and Culture, Genre, and elsewhere. He has been awarded fellowships by the National Endowment for the Humanities and the Social Science and Humanities Research Council of Canada. Currently, he is completing a book on the ocean, the Victorian novel, and the possibility of literal reading.





#### Katherena Vermette: A Reading and Conversation

Renowned Métis author Katherena Vermette will read from her work and engage in a conversation with Cree-Métis scholar Deanna Reder Chair of Indigenous Studies at Simon Fraser University, on a range of issues related to the conference theme, "Unsettling Victorians." As a writer who addresses colonial history and the ongoing legacy of colonial violence, gender oppression, and land dispossession in her fiction and poetry, Katherena Vermette's work powerfully speaks both to the erasure of Indigenous history and peoples and to new possibilities of futurity for Métis and Indigenous communities.



Katherena Vermette (she/her/hers) is a Red River Métis (Michif) writer from Treaty 1 territory, the heart of the Métis Nation. She has worked in poetry, novels, children's literature, and film. Born in Winnipeg, Manitoba, Canada, her father's roots run deep in St. Boniface, St. Norbert and beyond. Her mother's side is Mennonite from the Altona and Rosenfeld area (Treaty 1). Vermette received the Governor General's Literary Award for Poetry for her first book, *North End Love Songs* (The Muses' Company). *The Break* (House of Anansi) won several awards including the Amazon.ca First Novel Award, and was a bestseller in Canada. Her National Film Board documentary, *this river* won the Canadian Screen Award for Best Short. She holds a Master of Fine Arts from the University of British Columbia. Her second novel, *The Strangers* (Hammish Hamilton) won the Atwood Gibson Writers Trust Fiction Prize and was named Chapters Indigo's Book of the Year 2021. It was also longlisted for the Giller Prize.
